## PARKING EXPECTATIONS:

*Vehicles parked on Marshall Academy property are under the jurisdiction of the school.*

- Driving to school and parking on the school campus is a privilege, NOT A RIGHT.
- Any student wishing to park a vehicle in the parking lot is required to acquire a permit PRIOR to driving on campus.
- It is important for campus safety to know who is here among our students.
- Permission to park in the parking lot is granted subject to all rules and regulations of the school. By entering the parking lot, the person driving the vehicle is giving consent to a complete search of the vehicle by school officials or the police. The school reserves the right to search any vehicle if reasonable suspicion exists to do so, with or without the presence of the student.
- A student will be held responsible for any prohibited objects or substances such as alcohol, drugs, and weapons that are found in said vehicle and may be subject to disciplinary action by Marshall Academy, as well as referred for criminal prosecution.
- If a student's vehicle is found on campus without a permit, the student driver and parent will be required to provide proof of license and insurance.
- PLACEMENT: Parking permit must be visible from outside of the vehicle.
- Sharing parking permits is NOT permitted.

- A student has full responsibility for the security of vehicle and must make certain it is locked and that the keys are not given to others.
- Any student parked in a handicapped parking space, without handicapped permit, in a striped area, or in a space other than is designated for students, is subject to the vehicle being ticketed or loss of parking privileges.
- Any type of reckless driving (speeding, driving over curbs, etc.) on Marshall Academy property at any time (school day/non-school day) will result in suspension of driving privileges.
- Lost or stolen parking permits will have to be replaced.

**Students are expected to follow the expectations or privileges will be revoked.**
